The undersigned, for the purpose of forming a corporation under the Alabama Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be YOGURT YOUR WAY, INC.

ARTICLE II: AUTHORIZED CAPITAL STOCK

The total authorized capital stock shall be One Thousand and No/100 Dollars (\$1,000) consisting of 1,000 shares of common stock of the par value of One Dollar (\$1.00) per share. The amount of capital stock issued and outstanding with which the corporation will begin business shall be One Hundred and No/100 Dollars (\$100.00), consisting of One Hundred shares of common stock of the par value of One Dollar (\$1.00) per share, all of which shall be paid in.

ARTICLE VI: OBJECT AND PURPOSES


The purpose or purposes for which the corporation is organized are:
