FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of July, 2006, Lesley E. Lewis and Eric V. Cooper, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for AmSouth Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. # 20060811000392300, said mortgage having subsequently been transferred and assigned to US Bank, N.A., as trustee for JP Morgan Mortgage Trust 2007-S1, ("Transferee"); and

Together with the non-exclusive easements to use the private roadways, common areas and Hugh Daniel Drive, all as more particularly described in the Greystone Residential Declaration of Covenants, Conditions and Restrictions dated November 6th, 1990, and recorded in Real 317, Page 260 and amended map as recorded in Map Book 30, Page 97, in the Probate Office of Shelby County, Alabama, and all amendments thereto.

The property is being conveyed herein on an "as is, where is" basis subject to any easements, encumbrances, and exceptions reflected in the mortgage and those contained in the records of the Office of the Judge of Probate of the county where the above described property is situated; and furthermore, this property is being conveyed without warranty or recourse, express or implied, as to title, use and/or enjoyment and will be subject to the right of redemption of all parties entitled thereto; and by accepting this deed, Grantee releases any and all claims whatsoever against the law firm representing the Grantor hereunder and the auctioneer conducting said foreclosure sale; and furthermore, this conveyance is subject to being declared null and void in





the event that the owner or a party claiming through the owner has filed a bankruptcy prior to the date of this foreclosure sale.
