







Parcel I:

All that property lying and situated in the SW 1/4 of the SE 1/4 and the SE 1/4 of the SW 1/4 of Section 13, Township 22 South, Range 1 West, situated in Shelby County, Alabama which are known and described as 2009 Tax Parcel ID Numbers 29-6-13-0-001-006.000 and 29-6-13-0-001-007.000.


Parcel II:

A part of the SW ¼ of the SE ¼ of Section 13, Township 22 South, Range 1 West, situated in Shelby County, Alabama, described as follows: Beginning at the Southwest corner of said SW ¼ of SE ¼; thence Northwardly along the West line of said SW ¼ of SE ¼ a distance of 6.319 chains to a point on the center line of the Louisville and Nashville Railroad right of way; thence Eastwardly at a deflection angle of 93 degrees 02 minutes to the right along the center line of said railroad right of way a distance of 1.60 chains to a point; thence Northwardly, parallel to the West line of said SW ¼ of SE ¼, a distance of 1.288 chains to a point, which is the point of beginning; thence continue Northwardly, parallel to the West line of said SW ¼ of SE ¼, a distance of 8.94 chains to a point; thence Eastwardly at right angle to the West line of said SW ¼ of SE ¼ a distance of 2.037 chains, more or less, to a point on the extension Northwardly of the West line of Church Street and the West line of Church Street a distance of 9.56 chains to a point, which point is 85 feet Northwardly at right angles to the center line of the Louisville and Nashville Railroad right of way; thence Westwardly, parallel to and 85 feet Northwardly of the center line of said right of way a distance of 5.45 chains, more or less, to the point of beginning.
