FORECLOSURE DEED

KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, DECEMBER 22, 2006, JAH C. LIN and SONIA VU LIN, husband and wife, as Mortgagors, executed a Real Estate Mortgage on the property hereinafter described to New Century Mortgage Corporation which is recorded as Document No. 20070307000104720, in the Office of the Judge of Probate, SHELBY County, Alabama on March 7, 2007 and subsequently assigned to DEUTSCHE BANK NATIONAL TRUST COMPANY AS TRUSTEE FOR THE REGISTERED HOLDERS OF MORGAN STANLEY ABS CAPITAL 1 INC. WHEREAS, Fran Clark was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said Mortgagee; and,





