ARTICLES OF INCORPORATION
of
Loop Ticket, Inc.
An Alabama Corporation

Pursuant to the provisions of the Alabama Business Corporation Act,
the undersigned hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be **Loop Ticket, Inc.**

ARTICLE II - CORPORATION STATUS

This corporation shall be a corporation as authorized by the Code of Alabama, 1975, as amended, §10-2B-2.02 and shall be governed by all laws governing or applicable to such corporation.

ARTICLE III - DURATION

The duration of the corporation is perpetual.

ARTICLE IV - PURPOSE

The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Alabama Business Act including, but not limited to:

(a) Advertising, Marketing and Public Relations.

(b) To do everything necessary, proper, advisable, suitable or convenient for the accomplishment of the objects and purposes specified in this Paragraph IV, and to do all other things incidental therein, connected therewith, conducive thereto, or expedient therefor.

(c) To engage in any and all lawful businesses, enterprises, joint ventures, partnerships, limited liability companies and other legal business.

ARTICLE V - AUTHORIZED SHARES

The aggregate number of shares which the corporation shall have the authority to issue is FOUR HUNDRED (400) SHARES. These shares are to have a par value of ONE DOLLAR (\$1.00) EACH.

ARTICLE VI - REGISTERED OFFICE

The street address of the registered office is 4000 Eagle Point Corporate Drive, Birmingham, Alabama 35242 and the name of the registered agent at that office is Maleah Barton.

ARTICLE VII - DIRECTORS

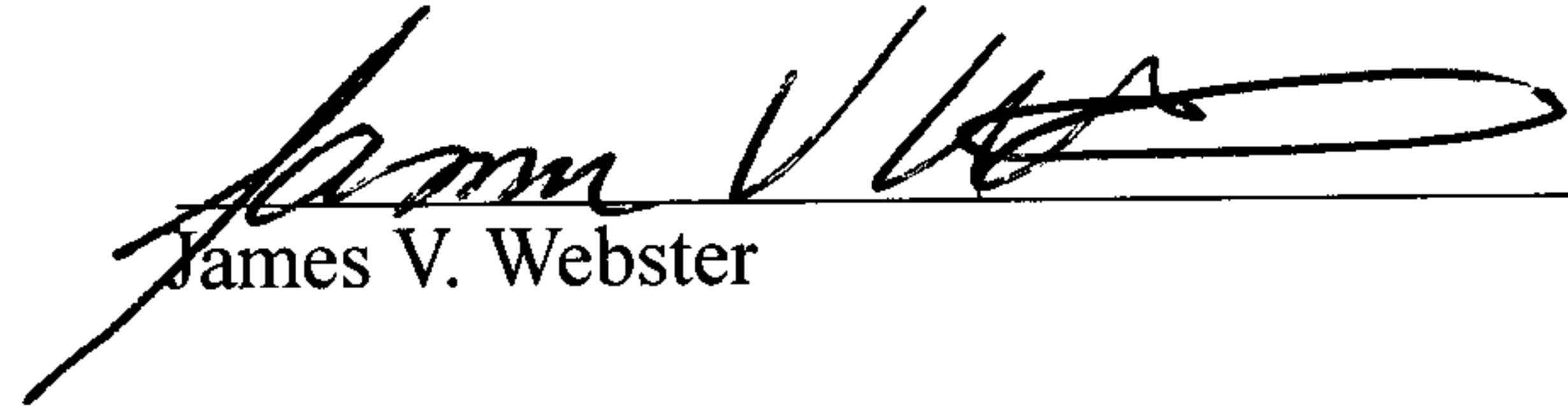

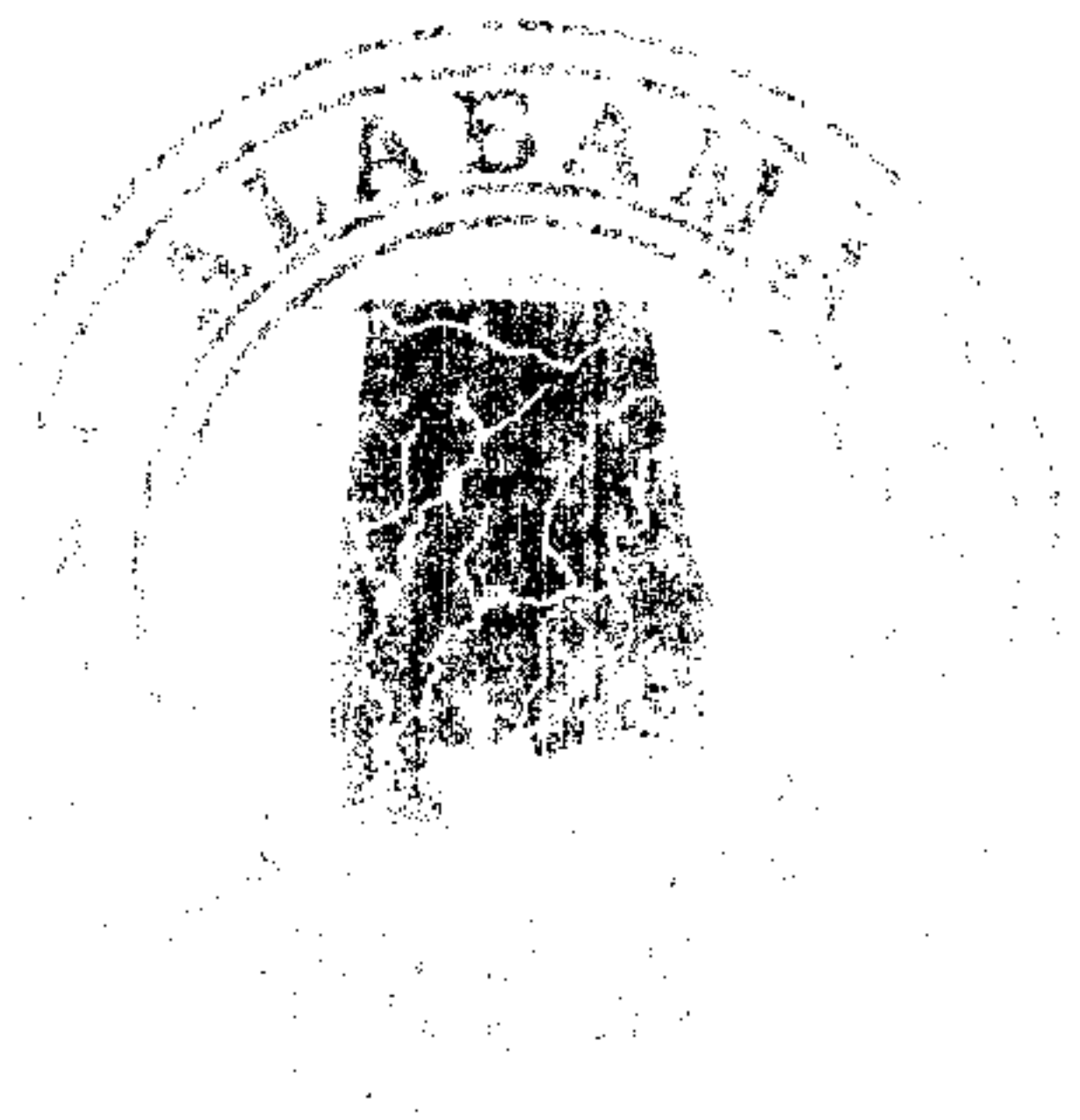
