**Article V - Registered Office and Agent**

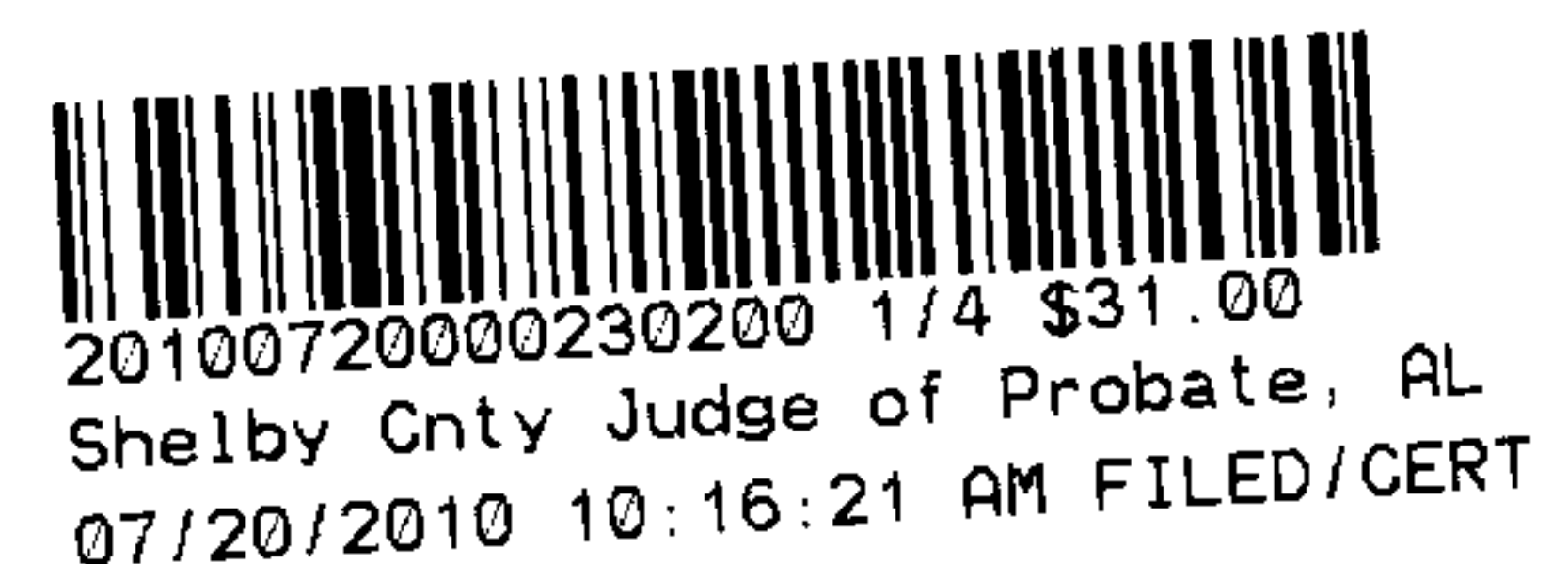

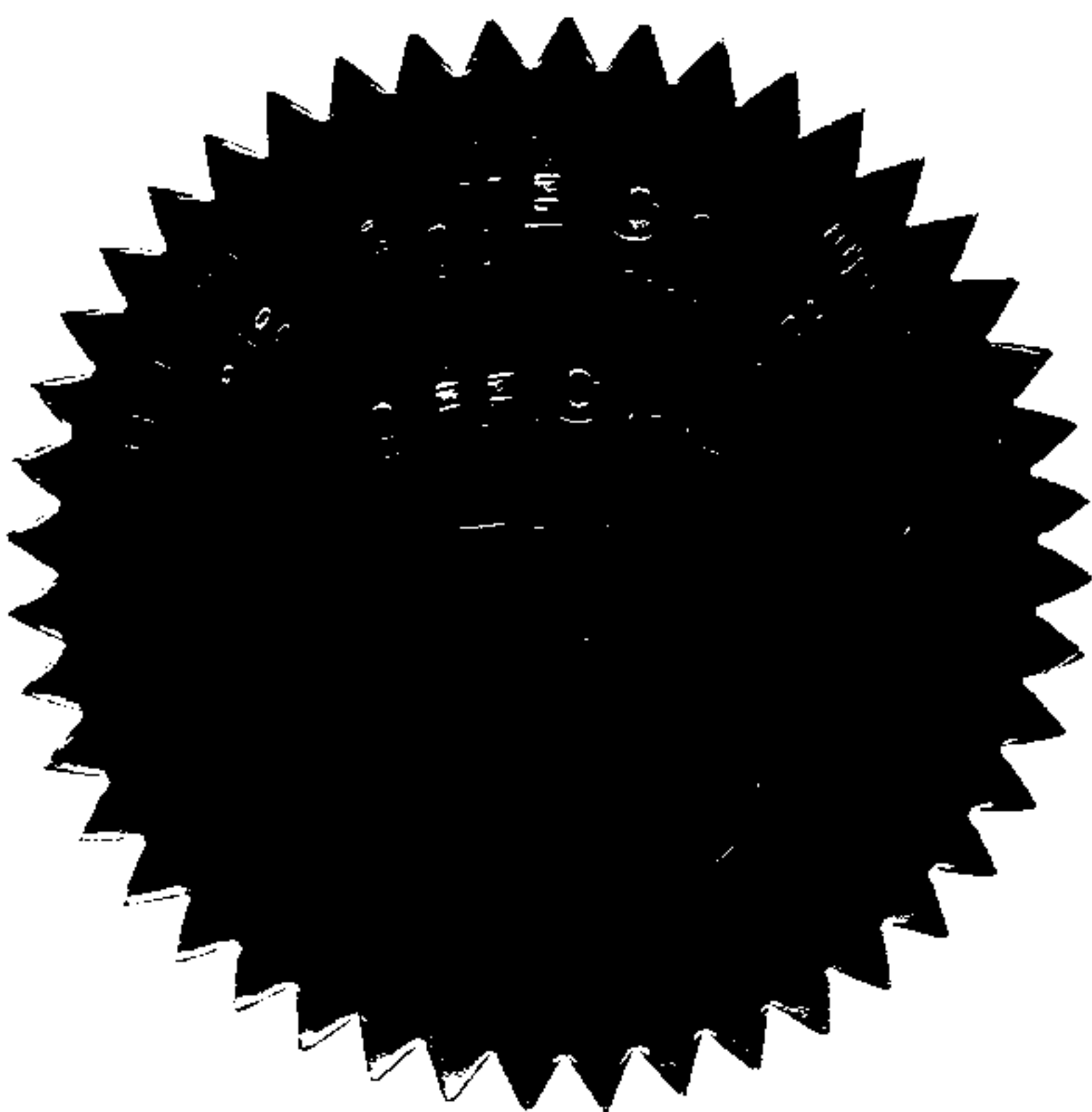
