FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of July, 2008, Jason Glas and Marsha Glas, Husband and Wife, executed that certain mortgage on real property hereinafter described to BancorpSouth Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. No. 20080723000296890 (Mortgagee), and
