

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One Dollar and other good and valuable consideration, to the undersigned grantors, in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, we, Will Brantley and wife, Lois Brantley (herein referred to as grantors), do grant, bargain, sell and convey unto our daughter, Freddie Brantley, (herein referred to as GRANTEE), the following described real estate situated in Shelby County, Alabama to-wit:
