KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **Six Hundred Eighty Thousand dollars and Zero cents** (**\$680,000.00**) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Robin C. Snable and husband, Anthony D. Snable** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **William C. Grantham and Sharon L. Grantham as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama**:

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


\$417,000.00 of the consideration recited herein is from the proceeds of a purchase money mortgage of even date herewith.


