# **ARTICLE I**

#### NAME

# **DURATION**

# **PURPOSES**

# ADMISSION OF ADDITIONAL MEMBERS

No person may be admitted as an additional member without the unanimous consent of the members.

# ARTICLE VII

#### CONTINUATION OF BUSINESS

Upon the occurrence of an event of dissociation which terminates the continued membership of a member, the remaining members may continue the legal existence and business of the Company if (i) there is at least one remaining member or a new member is admitted, and (ii) all of the members consent in writing to the continuation of the business within 90 days after the occurrence of the event of dissociation.

# ARTICLE VIII

#### MANAGEMENT

The Company shall be managed by the managing members pursuant to the Operating Agreement.

### ARTICLE IX

Any amendment to these Articles of Organization shall require approval of all the members.
