KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 11th day of December, 2001, Andre L. Brown and Angelia H. Brown, husband and wife, executed that certain mortgage on real property hereinafter described to Charter One Mortgage Corp., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 2001-55667, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument No. 20020710000318060, in the aforesaid Probate Office ("Transferee"); and
