FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of February, 2001, Ronald M. Woodard and wife, Louise S. Woodard, husband and wife, executed that certain mortgage on real property hereinafter described to Southeastern Mortgage of Alabama, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 2001-06464, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc, by instrument recorded in Instrument No. 20100525000165960, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, on July 27, 2010, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and CitiMortgage, Inc. did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and
