KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Thirty-Four Thousand Six Hundred and 00/100 (\$134,600.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Professional Homebuilders, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Iva E. Wyatt and Tommy O. Wyatt, wife and husband**, (hereinafter referred to as GRANTEE), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 233, according to the Survey of Cedar Grove at Sterling Gate, Sector 2, Phase 5 as recorded in Map Book 28 page 91 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
