KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of August, 2003, Barry N. Gilliland, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., nominated solely as nominee for Wachovia Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst.
