

<u>ORDER</u>

THIS CAUSE came on for trial on the 13th day of July, 2010 and was submitted to the Court on the Defendant's Petition to Modify and Plaintiff's Answer and Counterclaim. The Final Judgment of Divorce was heretofore rendered on September 30, 2002 and subsequently modified on May 12, 2009. The Plaintiff, appearing individually, was represented by and through her attorney of record, Wendy Hartley. The Defendant appeared individually in Open Court. Upon consideration thereof, together with all of the legal evidence and ore tenus testimony by the Plaintiff and Defendant, the Court is of the opinion the following Order should be entered. Accordingly, it is

ORDERED, ADJUDGED and DECREED by the Court:

- 1. That the child support ordered to be paid by the Defendant to the Plaintiff for the support and maintenance of the minor children of the parties be and it hereby is reduced to Three Hundred Fourteen Dollars (\$314.00) per month effective February 1, 2010. The child support is set pursuant to Rule 32 Child Support Guidelines, Rule of Judicial Administration. The Child Support Guideline Form, Plaintiff's CS-41, Defendant's CS-41 and the CS-42, are filed in this cause.
- 2. That the Defendant is presently self-employed; therefore, an "Income Withholding for Support" shall be entered but <u>NOT SERVED</u> at this time until further Order of the Court.
- 3. That the Court finds an old arrearage of Eight Thousand Three Hundred Six and 36/100 Dollars (\$8,306.36) in child support payments due by the Defendant to the Plaintiff as required by the Final Judgment of Divorce heretofore rendered by the Court. Also, the Court finds a current arrearage amount of Two Thousand Five Hundred Ninety (\$2,590.00) from December 1, 2009 through June 30, 2010 in child support payments due by the Defendant to the Plaintiff as required by the Order heretofore rendered by the Court. The Court therefore renders a judgment



against the Defendant and in favor of the Plaintiff in the said amount, plus accrued interest until satisfied.

- 4. That the Plaintiff shall provide to Defendant any non-covered medical expense bills within the next ten (10) days and Defendant shall pay to the Plaintiff those medical bills within thirty (30) days.
 - 5. That all other relief herein requested be and the same is hereby denied.
