FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on February 21, 2004, Ralph William McKinzie, III, an unmarried man, executed a certain mortgage on the property hereinafter described to Amerquest Mortgage Company, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument No. 20040317000135720 and subsequently transferred and assigned to Deutsche Bank National Trust Company, as Trustee for Amerquest Mortgage Securities, Inc., Asset-Backed Pass-Through Certificates, Series 2004-R3, as instrument recorded in Instrument No. 200961802 aforesaid records; and




