

Know All Men by These Presents: That in consideration of Two hundred nineteen thousand nine hundred and no/100 (\$219,900.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, Larry D. Brown, a married man (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto Prince David McKinley and Kathy L. McKinley (herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 12, Block 13, according to the Survey of Broken Bow South, as recorded in Map Book 11, Page 82, in the Probate Office of Shelby County, Alabama.a
