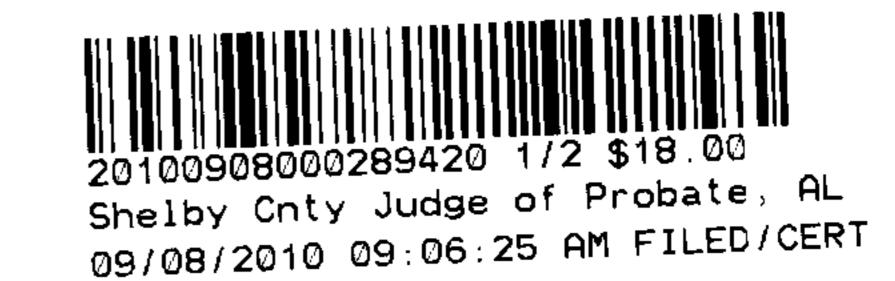

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, June 15, 2007, Kourtney Howze Means and husband, Eric R. Means wife and husband, Mortgagors, did execute a certain mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for First American Bank, which said mortgage is recorded in Instrument No. 20070619000287640, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, default was made in the payment of indebtedness secured by said mortgage, and the said Alabama Housing Finance Authority as transferee, did declare all of the indebtedness secured by said mortgage due and payable and did give due and proper notice of foreclosure of said mortgage, in accordance with the terms thereof, by First Class Mail and by publication in the Shelby County Reporter, a newspaper of general interest and circulation in Shelby County, Alabama, in its issues of 6/23, 6/30, 7/7/2010; and

WHEREAS, on July 22, 2010, the day on which the foreclosure sale was due to be held under the terms of said notice at 3.35 o'clock am/6m between the legal hours of sale, said foreclosure was duly and properly conducted and Alabama Housing Finance Authority did offer for sale and sell a public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Columbiana, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Alabama Housing Finance Authority in the amount of TWO HUNDRED THIRTY-ONE THOUSAND THREE HUNDRED FIFTY AND 14/100 DOLLARS (\$ 231,350.14) which sum the said Alabama Housing Finance Authority offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Alabama Housing Finance Authority; and
