SATISFACTION OF NOTE AND RECORDED MORTGAGE



Commence at the Southeast corner of the SW 1/4 of the NE 1/4, Section 34, Township 24 North, Range 15 East; thence run West along the South line of said 1/4-1/4 Section a distance of 578.09 feet; thence turn an angle of 82 degrees 00 minutes to the right and run a distance of 425.15 feet; thence turn an angle of 6 degrees 01 minutes to the left and run a distance of 102.40 feet; thence turn an angle of 96 degrees 30 minutes to the right and run a distance of 150.0 feet to the point of beginning; thence continue in the same direction a distance of 112.43 feet to a dirt road; thence turn an angle of 122 degrees 16 minutes 30 seconds to the left and run along said dirt road a distance of 117.43 feet; thence turn an angle of 57 degrees 43 minutes 30 seconds to the left and run a distance of 61.00 feet; thence turn an angle of 96 degrees 30 minutes to the left and run a distance of 100.0 feet to the point of beginning; situated in the SW 1/4 of the NE 1/4, Section 34, Township 24 North, Range 15 East, Shelby County, Alabama.
