KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of November, 2007, Wendy N. Branton and David M. Payne, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Alethes, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. No. 200711290000541650, said mortgage having subsequently been transferred and assigned to GMAC Mortgage, LLC, by instrument recorded in Instrument Number 2010729000242410, in the aforesaid Probate Office ("Transferee"); and


