

Commence at the Northwest corner of the Northeast quarter of the Northwest quarter of Section 23, Township 19 South, Range 2 West, Shelby County, Alabama and run thence South 88 degrees, 7 minutes, 26 seconds East along the North line of said quarter - quarter section a distance of 67.67 feet to a found rebar corner and the point of beginning of the property being described; thence continue last described course along an existing fence line a distance of 454.48 feet to a found rebar corner; thence run South 37 degrees, 9 minutes, 17 seconds West along an existing fence line a distance of 739.81 feet to a found rebar; thence run South 28 degrees, 20 minutes, 45 seconds West a distance of 20.02 feet to a found solid bar corner in the centerline of a thirty foot roadway easement; thence run North 5 degrees, 59 minutes, 35 seconds West along said centerline of said easement a distance of 534.04 feet to a found rebar corner; thence run North 32 degrees, 26 minutes, 23 seconds East along centerline of said thirty foot a distance of 107.84 feet to the point of beginning.
