Encroachment Agreement

STATE OF ALABAMA SHELBY COUNTY

The undersigned C. John Cortopassi and Donna C. Cortopassi ("Cortopassis") are the fee simple owners of the real property described as Lot 11, according to the map and survey of Lake Wellington Estates as recorded in Map Book 38, Page 90, in the Probate Office of Shelby County, Alabama.

A survey prepared by Jerry W. Cockrell dated August 17, 2010 which is attached to this Encroachment Agreement as Exhibit "A" ("Survey") shows that a wooden swing, and portions of a path made of decorative stone and a portion of a water fall which improved the Cortopassis' property described above encroaches on the property described as Lot 1, according to the Survey of Weavers Suddivision, as recorded in Map Book 31, page 1, in the Probate Office of Shelby County, Alabama. This Lot 1 is currently owned by Denise W. Weaver but is being conveyed to Jessica B. Balentine pursuant to the terms of a real estate sales contract dated June 24, 2010.

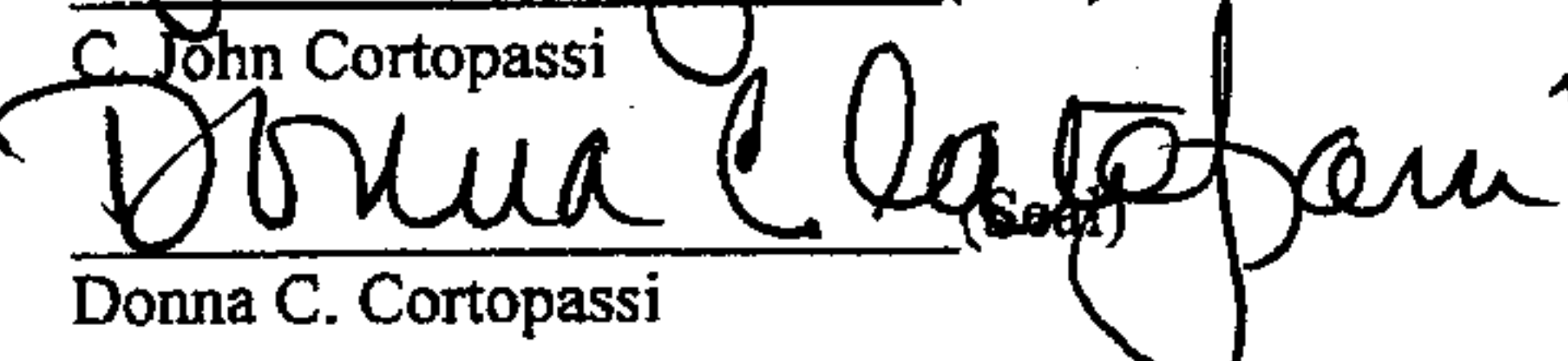
The Cortopassis acknowledge that Denise W. Weaver is aware of these encroachments and allows the encroachments to remain on Lot 1 with her permission and the Cortopassis hereby waive any claim to any ownership interest in Lot 1 by adverse possession.

Jessica B. Balentine will also allow the encroachments to remain on Lot 1. In consideration of allowing these encroachments to remain on Lot 1, C. John Cortopassi and Donna C. Cortopassi hereby agree to be solely responsible for the safety, upkeep and maintenance of these encroachments and further agree to hold harmless and indemnify, including attorney fees and court costs, Jessica B. Balentine and Bryan L. Balentine for any claims or demands arising out of or relating to any property damage or personal injury that occur during the use of these items which encroach on Lot 1.

This Encroachment Agreement shall run with the land and shall be binding on any future owners of the properties described.

This Encroachment Agreement has been prepared without the benefit of a title examination of Lot 11.

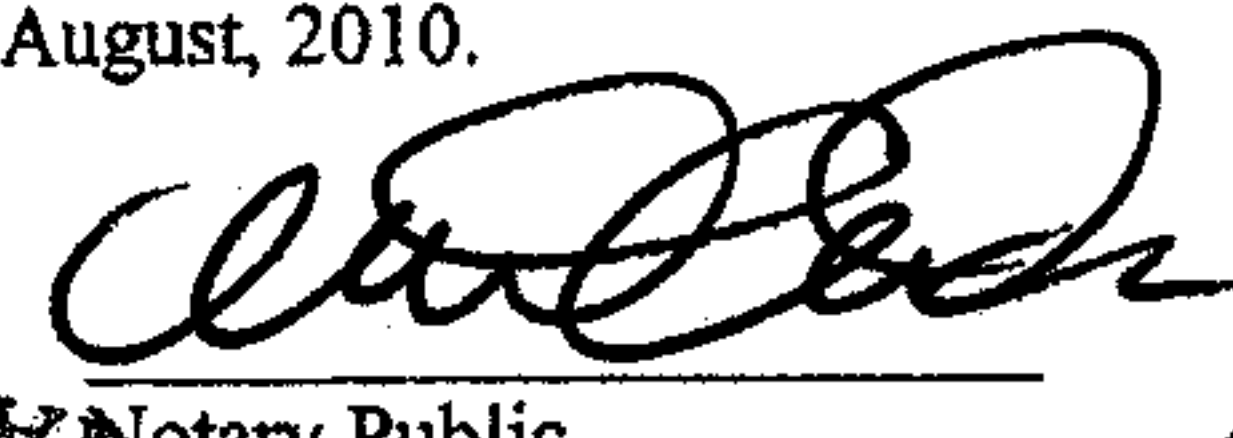
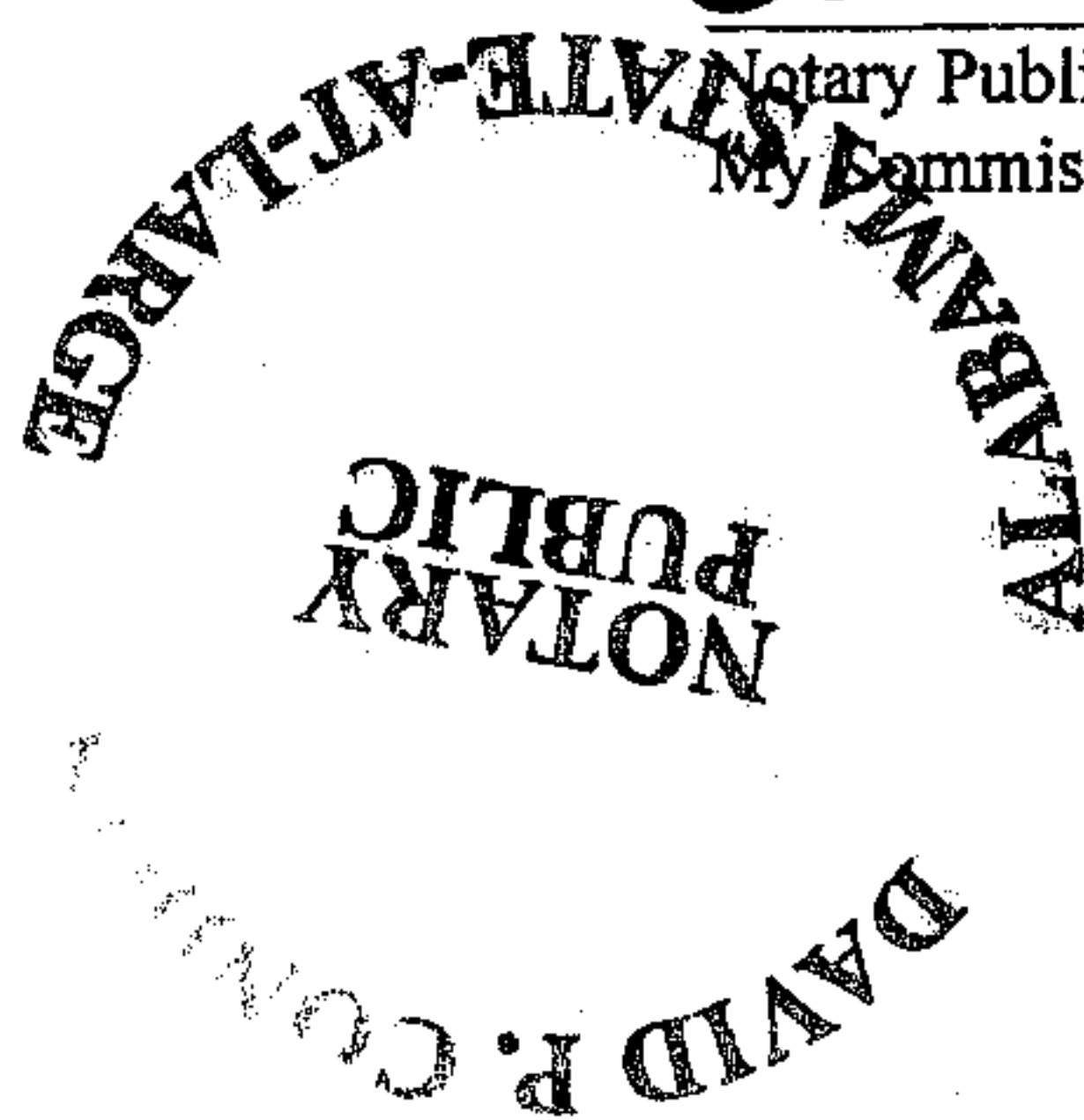
