

**ARTICLES OF ORGANIZATION OF
21st EQUITY HOMES MANUFACTURING (ALABAMA) LLC**

Pursuant to the Provisions of Sections 10-21-1 of the Code of Alabama (1975) as amended (the "Alabama Limited Liability Company Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE ONE

The name of the company shall be 21st EQUITY HOMES MANUFACTURING ALABAMA LLC

ARTICLE TWO

The period of duration shall be for a period of thirty-five (35) years, unless the Members agree to extend its duration or the Company is dissolved and its affairs wound in accordance with the Alabama Limited Liability Company Act.

ARTICLE THREE

The purpose for which the Company is formed is to engage in any lawful act or an activity of which limited liability companies may be organized pursuant to the Act.

ARTICLE FOUR

The location and street address of the initial registered office of the Company shall be 1564 Laurens Street, Birmingham, Alabama 35242, and its registered agent at such address shall be Jerry R. Carr.

Upon the unanimous written consent of the members, the Company may permit the admission of additional members and the terms of their admission shall be set forth in the Company's Operating Agreement.

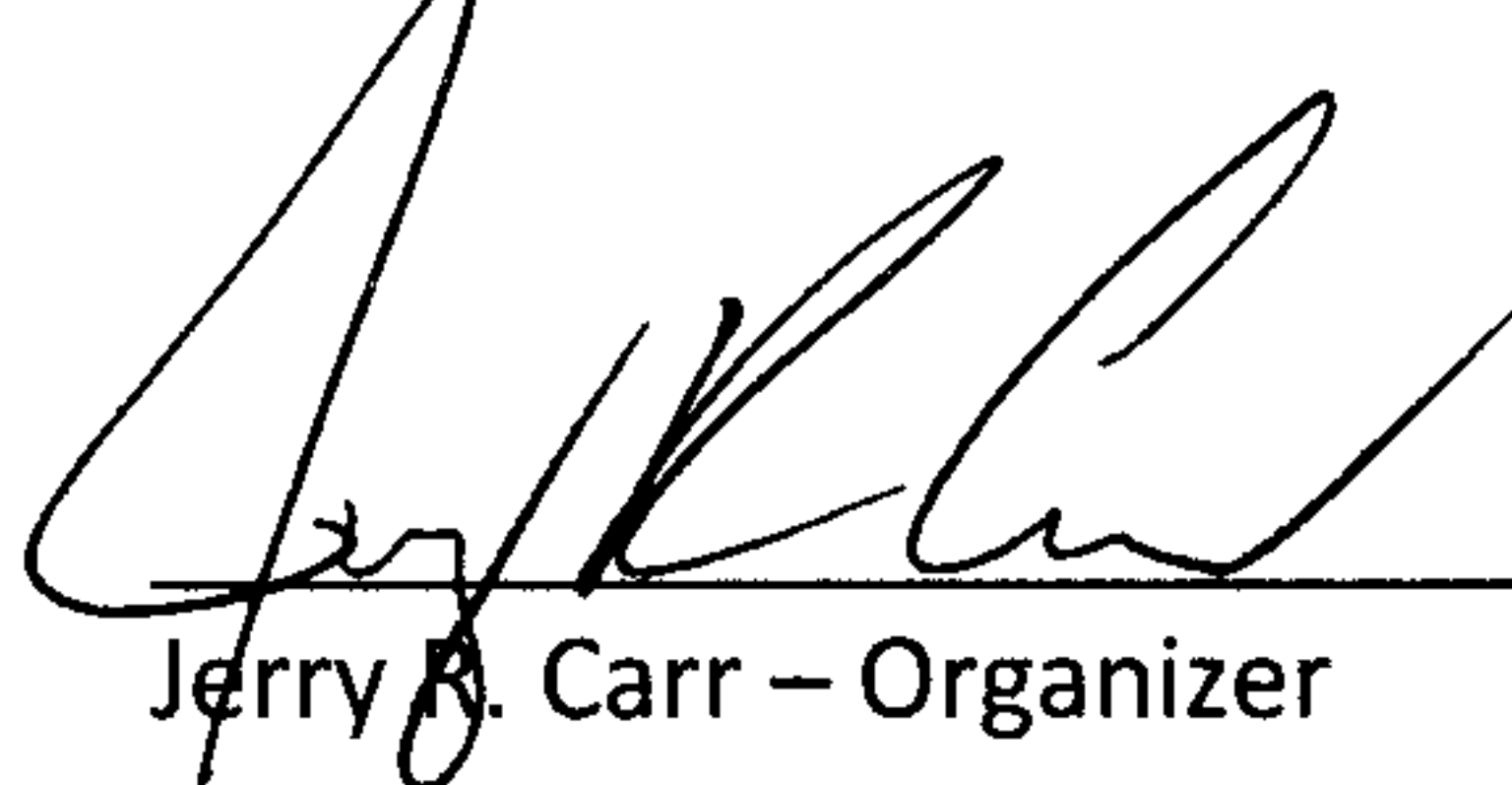
ARTICLE SEVEN

ARTICLE EIGHT

The Company shall be managed by its Members in accordance with the Act and as further set forth in the Company's Operating Agreement.
