
My name is Norma Nabors Rogers. I am the sole and surviving heir at law of Essie Nabors and L. H. Nabors, my Mother and Father. The said Essie Nabors having died on the 1st day of October, 1987, and L. H. Nabors having died on the 12th day of December, 1967 both of whom died intestate. I was their only child and I am the sole and surviving heir at law.

My parents left certain property located in Chelsea, Alabama, and which was situated in the NW 1/4 of the SW 1/4 and in the SW 1/4 of the NW 1/4, in Section 34, Township 19 South, Range 1 West, Shelby County, Alabama. I have sold certain portions of said property and now own only the following described land in said location, viz:

Commence at the Southwest corner of the Northwest 1/4 of the Southwest 1/4 of Section 34, Township 19 South, Range 1 West, Shelby County, Alabama and run thence Northerly along the West line of said 1/4-1/4 a distance of 740.13 feet to a point, thence turn a deflection angle of 91 degrees 28 minutes 23 seconds to the right and run Easterly a distance of 417.49 feet to the point of beginning of the property being described, thence continue along last described course a distance of 212.62 feet to a point in the asphalt pavement of the Chelsea School Parking lot, thence turn a deflection angle of 91 degrees 28 minutes 23 seconds to the left and run Northerly a distance of 1,050.00 feet to an existing steel pin corner found by this surveyor at a fence corner, thence turn a deflection angle of 88 degrees 07 minutes 57 seconds left and run Westerly along an existing fence a distance of 210.41 feet to an existing steel pin corner found by same said surveyor at a fence corner, thence turn a deflection angle of 91 degrees 44 minutes 42 seconds to the left and run Southerly a distance of 1,051.39 feet to an existing steel pin corner found by this surveyor and the point of beginning; being situated in Shelby County, Alabama.
