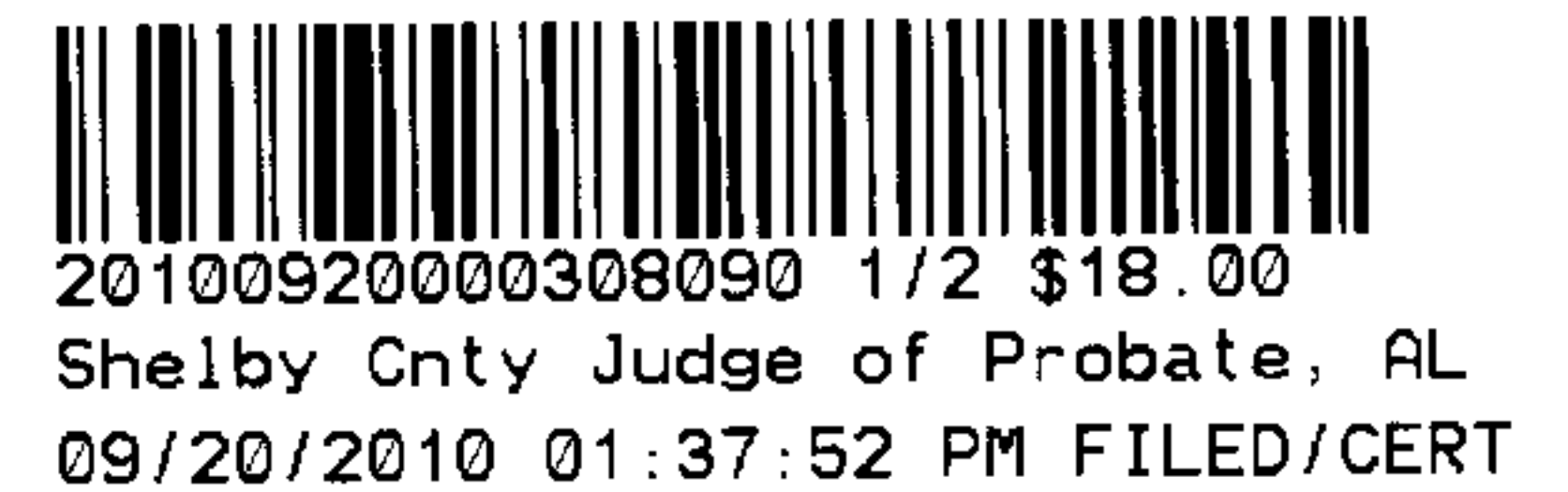

**MORTGAGE FORECLOSURE DEED**

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on December 21, 2007, **David S. Dean, individual and Holly M. Dean, husband and wife, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Suntrust Mortgage, Inc., its successors and assigns, party of the second part** which said mortgage is recorded in Instrument No. 20071228000581370, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to Suntrust Mortgage, Inc; Book 20100920000308090, Page \_\_\_\_\_ and

WHEREAS, default in the payment of the indebtedness secured by said mortgage, and Suntrust Mortgage, Inc did declare all of the indebtedness secured by the said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in the Shelby County Reporter, a newspaper of general circulation in Shelby County, Alabama, in its issues of 08/18, 08/25, 09/01/2010

WHEREAS, on September 9, 2010, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Suntrust Mortgage, Inc in the amount of **THREE HUNDRED FORTY-TWO THOUSAND NINETEEN AND 26/100 DOLLARS (\$ 342,019.26)**;, and said property was thereupon sold to Suntrust Mortgage, Inc; and
