**ARTICLES OF ORGANIZATION**

Pursuant to the Alabama Limited Liability Company Act, the undersigned hereby adopts the following Articles of Organization.

*Article I. Name of Limited Liability Company.* The name of this Limited Liability Company is Trinity Land Development, LLC.

*Article II. Duration.* The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.

*Article III. Purpose.* The Limited Liability Company is organized to develop, construct and manage commercial real estate and to further engage in any lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act; and to have all of the powers permitted by the Act, as amended from time to time.


