FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of September, 2004, James D. Holtzinger and Linda R. Holtzinger, his wife, executed that certain mortgage on real property hereinafter described to Union Planters Bank, NA d/b/a Regions Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20041004000545210, and
