KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 13th day of September, 2001, Felix Quintana and his wife Erica Quintana, executed that certain mortgage on real property hereinafter described to Regions Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 2001-40759, and
