ARTICLES OF ORGANIZATION

Pursuant to the Provisions of the Alabama Limited Liability Company Act, as amended, the undersigned hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the company is:

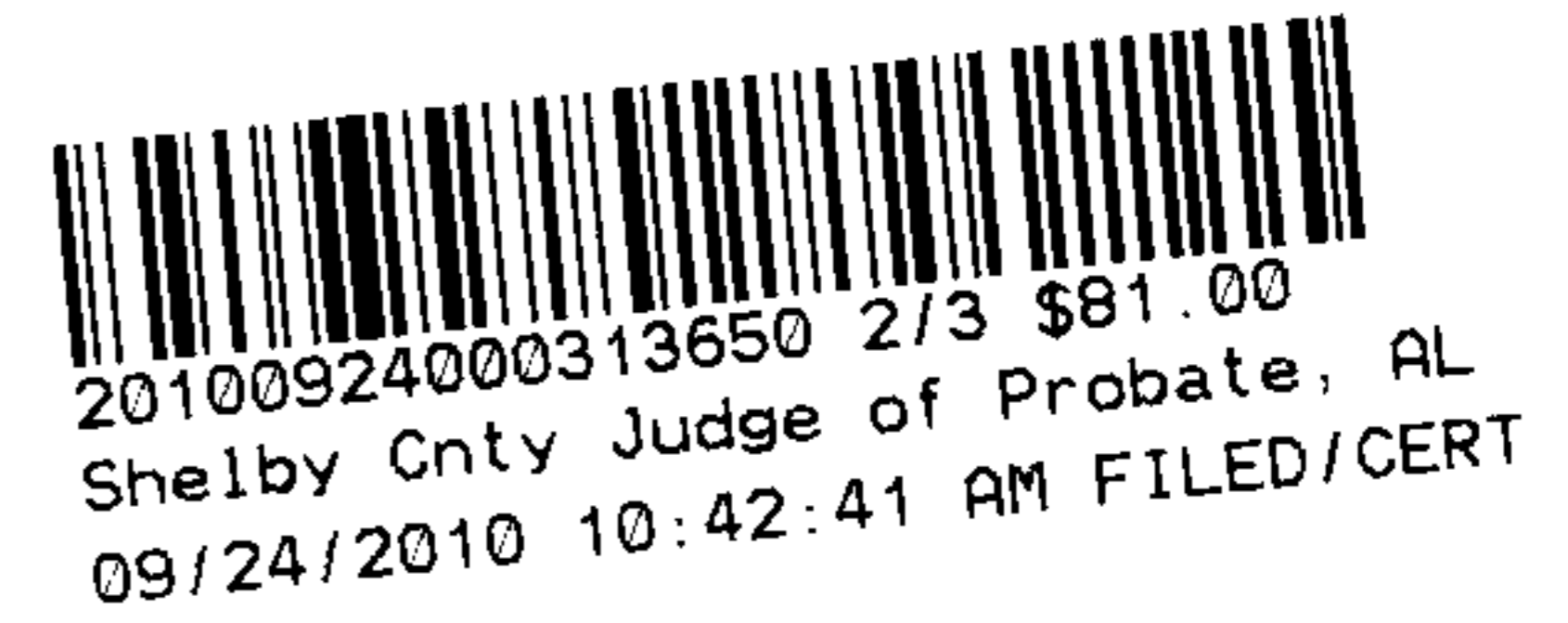

ARTICLE VI

Cessation of Membership

The legal existence and business of the Company may be continued by the written consent of all the remaining members after an event of disassociation of a member, unless otherwise specified by the Operating Agreement.

ARTICLE VII

Additional Members

The initial member shall have the right to admit additional members upon unanimous consent and agreement of the original members.

Any other provisions, not inconsistent with the law, which the members elect to set out in the Articles of Organization for the regulation of the internal affairs of the LLC, including any provisions, which under this act are required or permitted to be set out in the operating agreement of the LLC. It is not necessary to set out in the Articles of Organization any of the powers enumerated in the LLC Act.

ARTICLE VIII

Powers

Wallis Trucking, LLC adopts and is hereby governed by the powers set forth in § 10-12-1, et. seq. of the Code of Alabama.

ARTICLE IX

Taxation

Wallis Trucking, LLC elects to be treated as an S-Corporation for taxation purposes.
