KNOW ALL MEN BY THESE PRESENTS that in consideration in the sum of One Hundred Forty Thousand and 00/100 Dollars (\$140,000.00) paid by the Grantees herein, the receipt of which is hereby acknowledged, DONALD H. 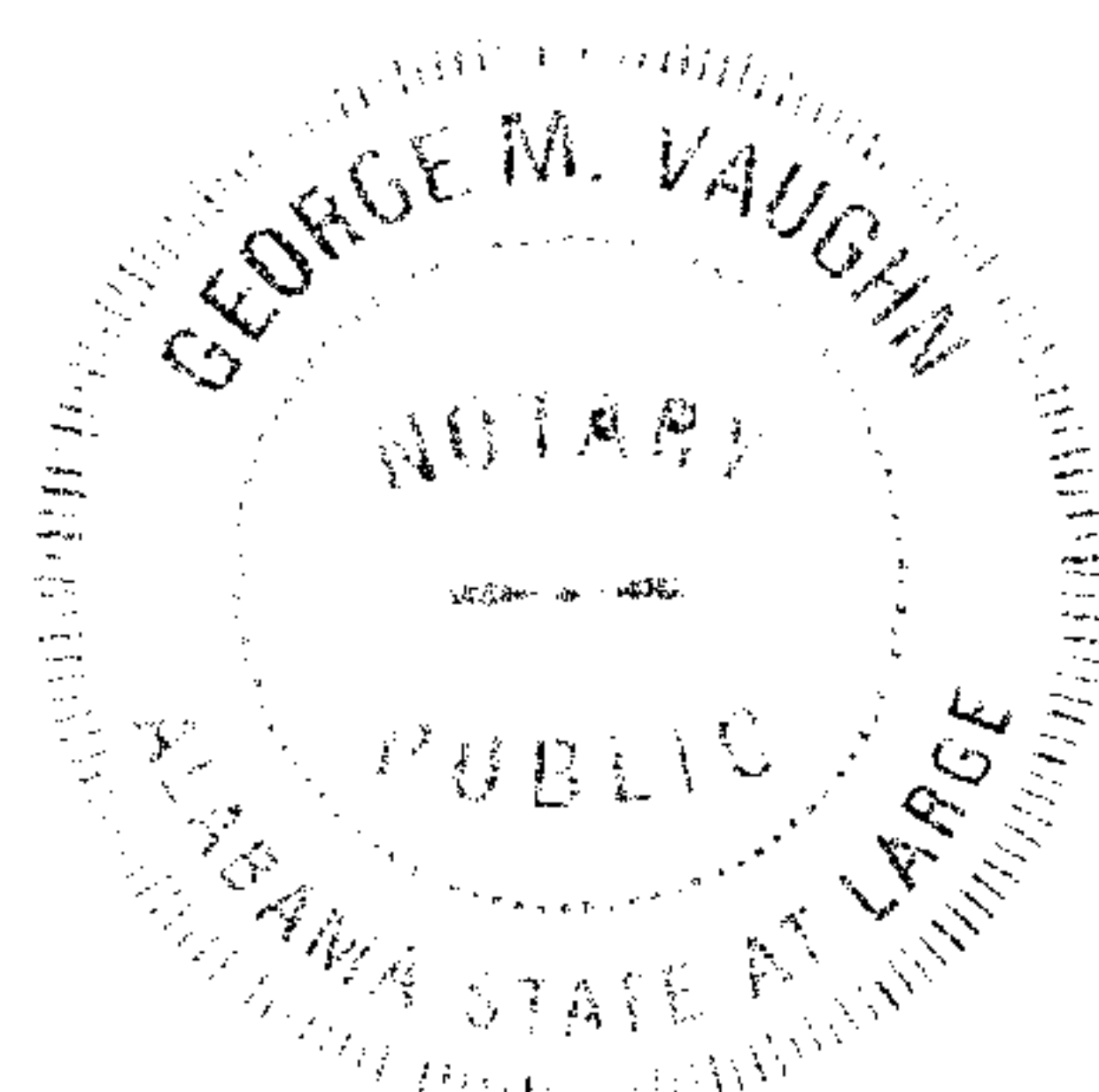
