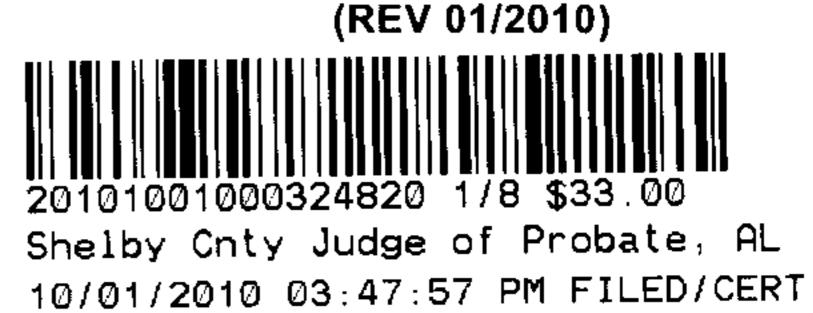

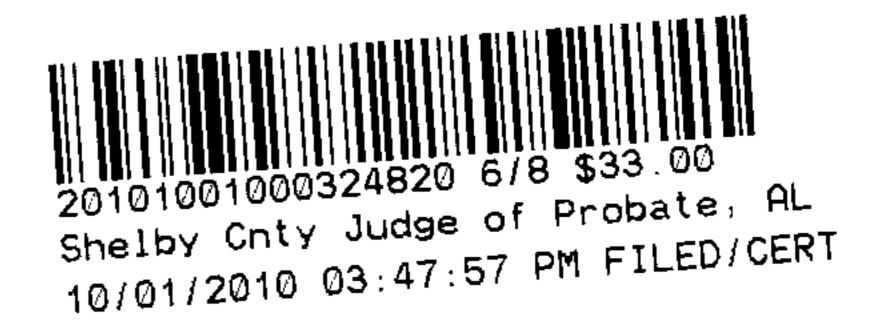
FORECLOSURE DEED

WHEREAS, heretofore, on, to-wit: the 31st day of July, 2001, Darren L. 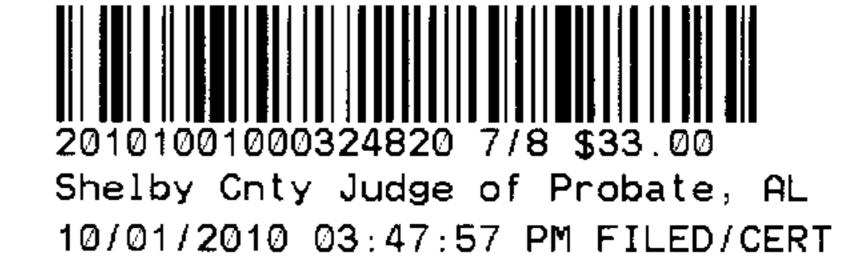

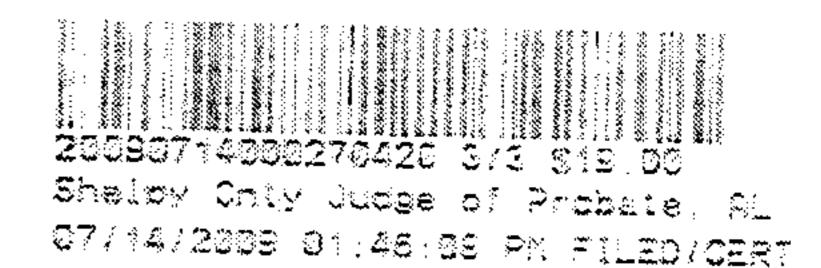

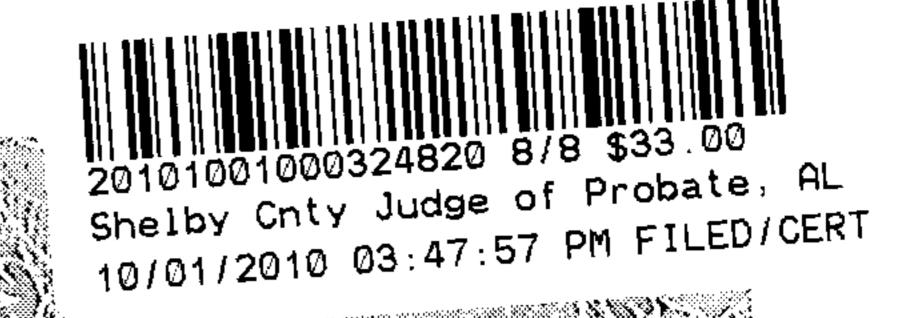
