**ARTICLES OF ORGANIZATION**  
**OF**  
**BLYTHE ENTERPRISES, LLC**  
An Alabama Limited Liability Company

Pursuant to the provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I**

*Name*

The name of the limited liability company is Blythe Enterprises, LLC, an Alabama Limited Liability Company (the "Company").

**ARTICLE II**

*Duration*

The Company shall have a duration from the date of organization until it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").

**ARTICLE III**

*Purposes*

The purpose for which the Company has been organized is to own and operate one or more "Great Clips" franchises, and to conduct any lawful act or activity for which limited liability companies may be organized pursuant to the Act.

**ARTICLE IV**

The cessation of membership of one or more members will not result in the dissolution of the Company.


## ARTICLE VIII
