

Begin at the Northeast corner of the NW ¼ of the NW ¼ , Section 27, Township 22 South, Range 3 West, Shelby County, Alabama and run thence Westerly along the North line of said quarter-quarter a distance of 375.50 feet to a point, thence turn an angle of 74 degrees 06 minutes 13 seconds left and run Southwesterly a distance of 146.93 feet to a point; thence turn an angle of 79 degrees 08 minutes 51 seconds to the left and run Southeasterly a distance of 689.49 to a point; thence turn an angle of 73 degrees 09 minutes 22 seconds left and run Northeasterly a distance of 30.0 feet to a point; thence turn an angle of 4 degrees 28 minutes 32 seconds left and continue Northeasterly a distance of 265.86 feet to a point; thence turn an angle of 3 degrees 30 minutes 57 seconds left and continue Northeasterly a distance of 275.05 feet to a point on the North line of the NE ¼ of the NW ¼ of same said Section 27; thence turn an angle of 125 degrees 36 minutes 05 seconds left and run Westerly along the North line of said quarter-quarter a distance of 548.50 feet to the point of beginning, and subject to all agreements, easements, restrictions, limitations, or applicable laws of probated record or statutory enactment.
