ARTICLES OF ORGANIZATION

**ARTICLE I** 

NAME OF COMPANY: The name of the limited liability company is THE

ARTICLE II

**DURATION:** The period of duration of the Company shall be from the date of filing of

these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama,

until the first to occur of the following:


(1) Fifty (50) years from the date of filing of these Articles of Organization; or




