

## Lien Subordination Agreement

THIS LIEN SUBORDINATION AGREEMENT ("Agreement") is made of the

15THday of SEPTEMBER , 2010 by ACIPCO FEDERAL

CREDIT UNION and HOMETOWN MORTGAGE SERVICES, INC., ("New Lender")

(collectively, the "Parties").

## **RECITALS:**

WHEREAS, Jerry Burns and wife, Rebecca Burns ("Borrowers") borrowed funds in the maximum principal amount of Fifty Thousand Dollars (\$50,000.00) from ACIPCO FEDERAL CREDIT UNION, said loan being evidenced by a promissory note, an equity line of credit agreement, or other obligation dated December 10, 2009 and recorded as Instrument Number 20100113000012160, in the Office of the Judge of Probate of Shelby County, Alabama. ("Mortgage"); and

WHEREAS, the Mortgage grants a lien on the property ("Property") described therein, which description is by this reference incorporated as if fully set out herein.


WHEREAS, Borrower desires to borrow from New Lender, and New Lender desires to lend to Borrower, funds in the maximum principal amount of \$\frac{276,500.00}{\text{outure}}\$, which loan will be evidenced by a Note or other obligation to be executed by Borrower in favor of New Lender ("New Note"), and which will be secured by a mortgage from borrower to New Lender ("New Mortgage"); and

WHEREAS, New Lender is unwilling to make the above-referenced loan to Borrower unless the New Mortgage has priority over, and is senior to, the lien of the Mortgage.

## NOW, THEREFORE, the Parties agree as follows:

- 1. ACIPCO FEDERAL CREDIT UNION hereby subordinates the Mortgage and the lien thereof to the New Mortgage, up the Maximum Principal Amount of the New Mortgage. To the extent that New Lender extends to Borrower any amount over and above the Maximum Principal Amount of the New Mortgage, and to the extent of any interest, fees, premiums, penalties, charges, costs, and expenses relating thereto, the Mortgage and the lien thereof shall have priority over the New Mortgage.
- 2. The New Mortgage upon the property described therein shall be superior and senior to the lien of the Mortgage, up to the Maximum Principal Amount, as provided above, and to carry out such purpose, ACIPCO FEDERAL CREDIT UNION does hereby release, remise, and forever quitclaim its title to, and lien upon, the Property to the extent, but only to the extent that the Mortgage shall be subordinate and junior to the New Mortgage, up to the Maximum Principal Amount, as provided above. The foregoing subordination applies only to the New Mortgage and does not affect the lien of the Mortgage with respect to any other matters of title affecting the Property.

- 3. Except for the subordination of the Mortgage to the New Mortgage as set forth herein, the Mortgage and all the terms and conditions thereof shall be and remain in full force and effect.
- 4. All references herein to ACIPCO FEDERAL CREDIT UNION and New Lender shall include the heirs, successors, and assigns of such party, and all of the covenants, provisions, and agreements by or on behalf of any such party shall bind and inure to the benefit of the heirs, successors, and assigns of such party and the other parties hereto.
