FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on to-wit: the 21st day of May, 2008, Harbar Construction, Co., Inc., an Alabama Corporation, did execute a certain mortgage on property herein described to Superior Bank, which said mortgage is recorded as Document Number 20080603000223020 in the Office of the Judge of Probate of Shelby County, Alabama.

WHEREAS, on the 5th day of October, 2010, the day on which the foreclosure sale was to be held under the terms of said notice between the legal hours of sale, said foreclosure was duly and properly conducted and Superior Bank did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described:

WHEREAS, Thomas R.
