KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of April, 2006, Michael A Myrick and Kellie M Myrick, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20060501000202980, said mortgage having subsequently been transferred and assigned to EverHome Mortgage Company, by instrument recorded in Instrument No. 20100526000167140, in the aforesaid Probate Office ("Transferee"); and
