KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of March, 2002, Isaac A. Bratcher and wife, Robbie L. Bratcher, executed that certain mortgage on real property hereinafter described to FirstBank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 2002-12784, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc. , by instrument recorded in Instrument Number 20100825000272540, in the aforesaid Probate Office ("Transferee"); and
