WHEREAS, on the 17<sup>th</sup> day of April, 2007, John Luther filed a petition with the Town of Westover, Alabama, as required by §§ 11-42-20 and 11-42-21, Code of Alabama 1975, as amended, petitioning and requesting that the property hereinafter described be annexed to the municipality of the Town of Westover, Alabama, which petition contained an accurate description of the property proposed to be annexed together with a map of the said property showing its relationship to the corporate limits of the Town of Westover, Alabama, and the signatures of the owners of the property described were signed thereto;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WESTOVER, ALABAMA, AS FOLLOWS:

1. That the Town of Westover, Alabama, does adopt this Ordinance assenting to the annexation of the following described property to the municipality of the Town of Westover:

Commence at the SW corner of the SW 1/4 of the NE 1/4 of Section 23, Township 19 South, Range 1 East; thence run North along the West line of said 1/4 1/4 Section 329.65 feet to a point; thence turn 88 deg. 45 min. 43 sec. right and run Easterly 561.62 feet; thence turn 88 deg. 58 min. 37 sec. right and run Southerly 424.56 feet to a point on the North right of way line of Old U. S. Highway No. 280; thence turn right 63 deg. 22 min. 23 sec. and run South Westerly along said right of way line 566.25 feet; thence turn 112 deg. 01 min. 51 sec. right and run Northwesterly to the point of beginning, being a point on the Westover town limit line; thence continue along last described course to a point on the East line of the SE 1/4 of the NW 1/4 of said Section 23 which is 329.65 feet north of the SE corner of said 1/4/ 1/4; thence turn left 91 deg. 14 min. 17 sec. from the east line of said 1/4 1/4 and run Westerly 329.30 feet; thence turn 88 deg. 47 min. 23 sec. left and run Southerly to the south line of said 1/4 1/4 and the Westover town limit line; thence turn left and run east along the Westover town limit line to the point of beginning.

2. That the corporate limits of the Town of Westover, Alabama, be extended and rearranged so as to embrace and include such property, and such property shall become a part of the corporate area of such municipality upon the date of publication or posting of this Ordinance, as provided for in the Code of Alabama as cited above.

3. That the Town Clerk be and he is hereby authorized and directed to file a copy of this Ordinance, including an accurate description of the property being annexed, together with a map of the said property showing its relationship to the corporate limits of the Town of Westover, Alabama, to which said property is being annexed, in the office of the Judge of Probate of Shelby County,


Alabama.

4. That the Zoning Map of the Town of Westover, Alabama, and any other official maps or surveys of the Town shall be amended to reflect the annexation of the above-described property, and that a copy of this Ordinance be transmitted to the Town Planning Commission.

5. That this property is zoned AP as provided in the Zoning Ordinance of the Town of Westover, Alabama.

This ordinance was adopted and passed by the Town Council of the Town of Westover, Alabama, this the 17<sup>th</sup> day of April, 2007.






