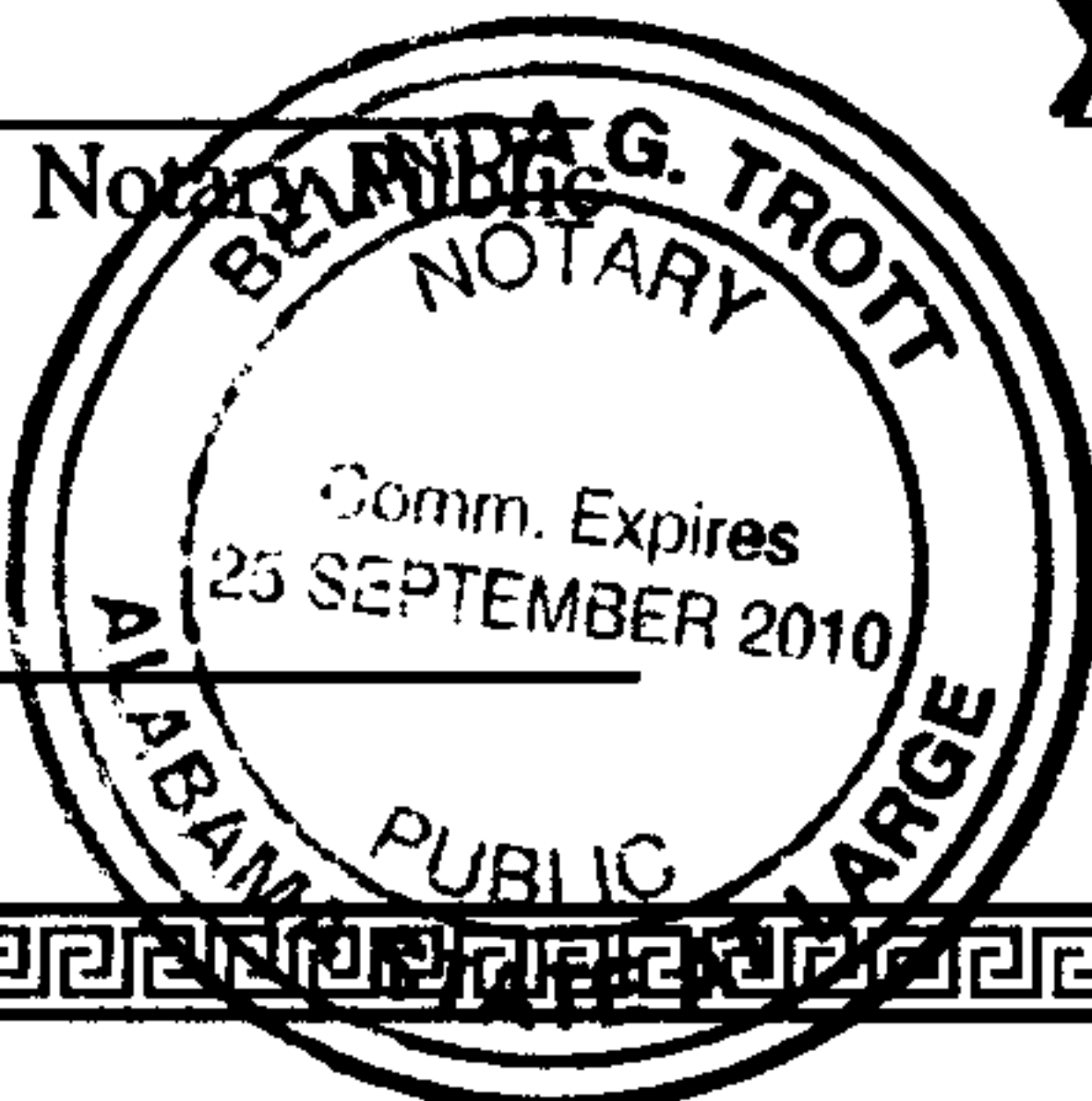
Oath of Office

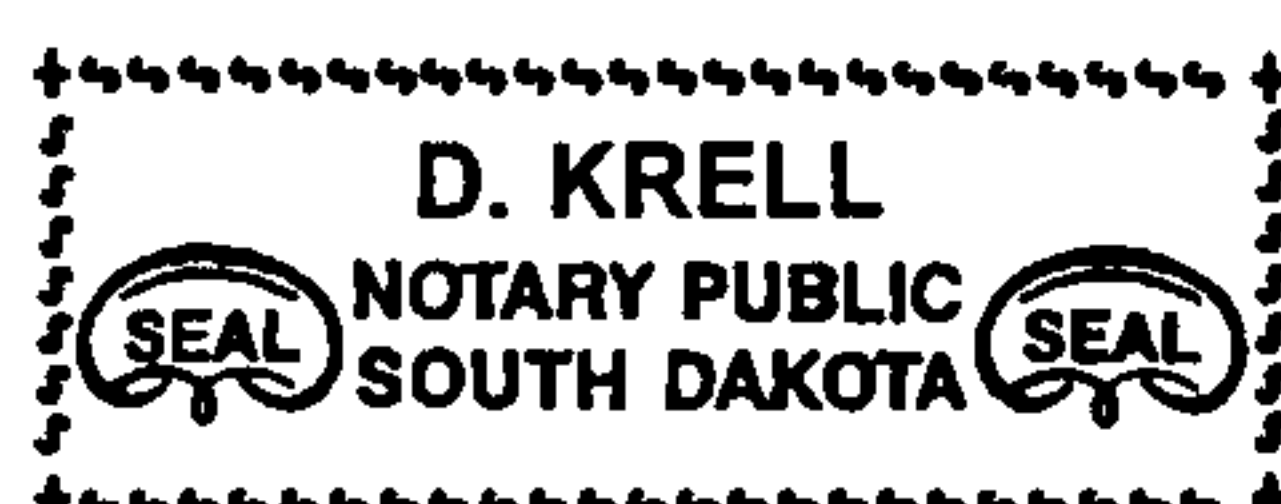
