KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of March, 2002, Christopher Shane Oglesby a/k/a Christopher S. 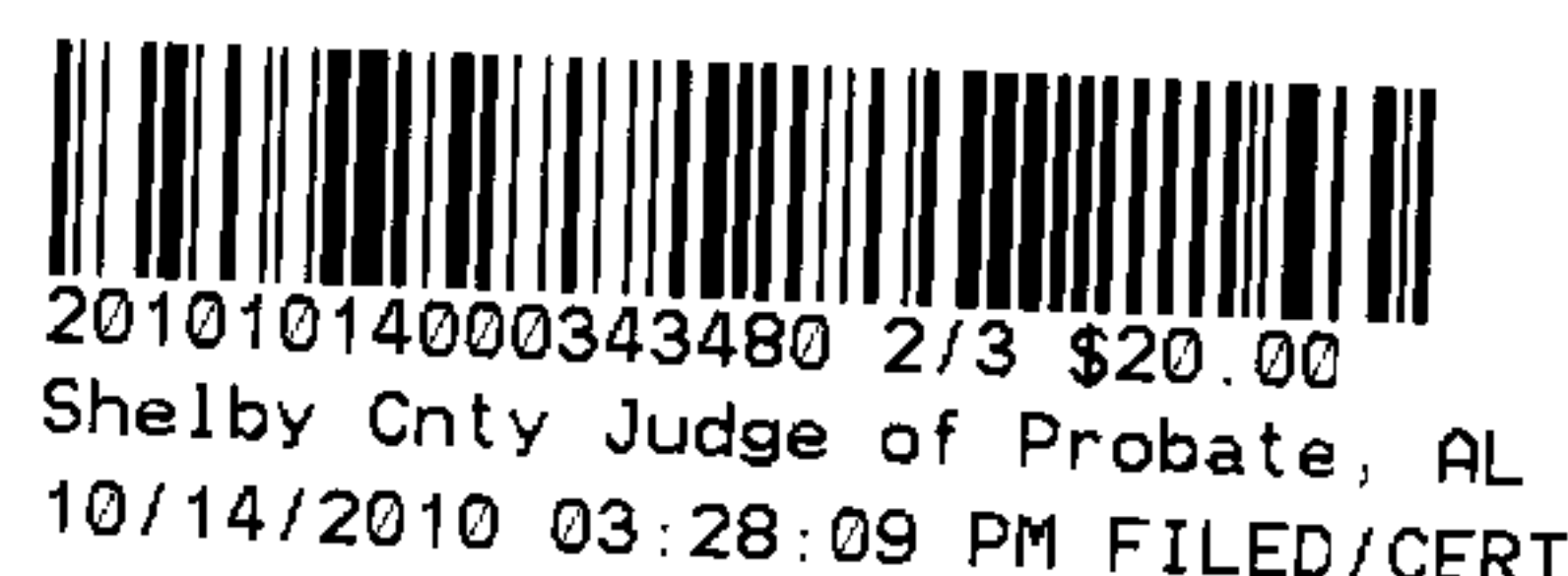
