FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of February, 2001, Paul L. Goode a single person, executed that certain mortgage on real property hereinafter described to Charter One Mortgage Corp., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument number 2001-03958 and corrected and re-recorded in Instrument Number 2001-25922, said mortgage having subsequently been transferred and assigned to Wells Fargo Home Mortgage, Inc., by instrument recorded in Instrument Number 2001-25028, in the aforesaid Probate Office ("Transferee"); and




