**WARRANTY DEED AND LIMITED POWER OF ATTORNEY**

**KNOW ALL MEN BY THESE PRESENTS:** That in consideration of Eighty Four Thousand Six Hundred and 00/100 Dollars\*\*\*\*\* (\$ 84,600.00\*\*\*\*) to the undersigned Grantors in hand paid by the Grantees, whether one or more, herein, the receipt of which is hereby acknowledged, we, Osman Tunagur and Laurie Tunagur, husband & wife, (herein referred to as Grantors) do grant, bargain, s e l l a n d c o n v e y u n t o David Michael Doonan and wife, Kimberly Anne Doonan (hereinreferred to as Grantees) as individual owner or as joint tenants, with right of survivorship, if more than one, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

✓ Lot 48, according to the map and survey of Brandywine, First Sector, as recorded in Map Book 7, Page 7, in the Office of the Judge of Probate of Shelby County, Alabama; less and except the East 6.5 feet of said Lot 48.;


