KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of August, 2003, Donald T. Parker and Sheri F. Parker, a married couple, executed that certain mortgage on real property hereinafter described to CitiFinancial Mortgage Company, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20030908000598570, and
