(herein referred to as Grantor, whether one or more), grants, bargains, sells, and conveys unto

JAMES F. DAVIES AND MARY E. DAVIES, TRUSTEES, OR THEIR SUCESSORS IN TRUST, UNDER THE DAVIES LIVING TRUST, DATED AUGUST 31, 2000 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:
