KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 18th day of January, 2007, Jennifer Keel a married woman, joined by her husband, Phillip Sean Keel, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Homecomings Financial, LLC (f/k/a Homecomings Financial Network, Inc.), which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst.
