

SUBORDINATION AGREEMENT

This Subordination of Mortgage is executed this $\frac{125}{2}$ day of October, 2010 by Alabama Telco Credit Union.

WITNESSETH

WHEREAS, Alabama Telco Credit Union is the owner and holder of that certain mortgage from Jeffery S. Smith and his wife Meredith M. Smith recorded in Instrument 20071004000464490 in the Probate Office of Shelby County, Alabama, said property being more particularly described as follows:

Said Mortgage had a credit limit of Sixty-Five Thousand Seven Hundred (\$65,700.00) but has today been decreased to Twenty-One Thousand (\$21,000,00).

WHEREAS, Principal Mortgage, LLC is making a mortgage loan to Jeffery S. Smith and Meredith M. Smith in the amount of Three Hundred Thirty-Six Thousand and 00/100 Dollars (\$336,000.00) said loan secured by a mortgage which encumbers the real property described on Exhibit "A".

WHEREAS, Principal Mortgage, LLC as a condition for making a 1st mortgage loan requires Alabama Telco Credit Union to subordinate the lien of its mortgage to the lien of Principal Mortgage, LLC and Alabama Telco Credit Union has agreed to do so.

NOW, THEREFORE, for and in consideration of the premises hereof and of mutual advantages and benefits accruing to the parties hereto and in further consideration of the sum of Ten and 00/100 Dollars (\$10.00) in hand paid by Principal Mortgage, LLC to Alabama Telco Credit Union, the receipt and sufficiency of which is hereby acknowledged, Alabama Telco Credit Union does hereby covenant, consent and agree to and with Principal Mortgage, LLC that the lien of Alabama Telco Credit Union shall be and the same is hereby made subordinate, inferior and subject in every respect to the lien of Principal Mortgage, LLC which encumbers the above described property.
