

SPECIAL WARRANTY DEED/ JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP

This indenture, made on the <u>29th</u> day of October, 2010, by and between the **Secretary of Veterans Affairs**, and Office of The United States of America, whose address is **Department of Veterans Affairs**, Washington, DC 20420, (herein referred to as Grantor) does by these presents, grant, bargain, sell and convey unto **Jacob Lee Harvell and Kristy B**. **Harvell**, (herein referred to as Grantor(s) for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate the following described real estate, situated in **SHELBY** County, Alabama to wit:

Lot 2814, according to the Survey of Weatherly Highlands The Cove, Sector 28, Phase 1, as recorded in Map Book 27, Page 99, in the Office of the Judge of Probate of Shelby County, Alabama.
