### SUBORDINATION AGREEMENT

This agreement made and entered into this 29th day of October, 2010, by and between Robert G. Dorough and Bonita Dorough, (hereinafter called "Mortgagors"), and Superior Bank, (hereinafter called "Mortgagee").

### WITNESSETH

Superior Bank does hereby fully subordinate and does declare to be subordinate the aforesaid Mortgage in the original amount of \$30,000.00 filed for record 3/24/2010, recorded in Instrument No. 20100324000085360 in the Office of the Judge of Probate, Shelby County, Alabama, to the mortgage in favor of Superior Bank dated October 29, 2010 in the amount of \$417,000.00, recorded in 20101110000376540 in the Office of the Judge of Probate of Shelby County, Alabama, and to the mortgage in favor of Superior Bank dated July 30, 2009 in the amount of \$183,000.00, filed for record 8/21/2009, recorded in Instrument No. 20090821000323380 in the Office of the Judge of Probate, Shelby County, Alabama.

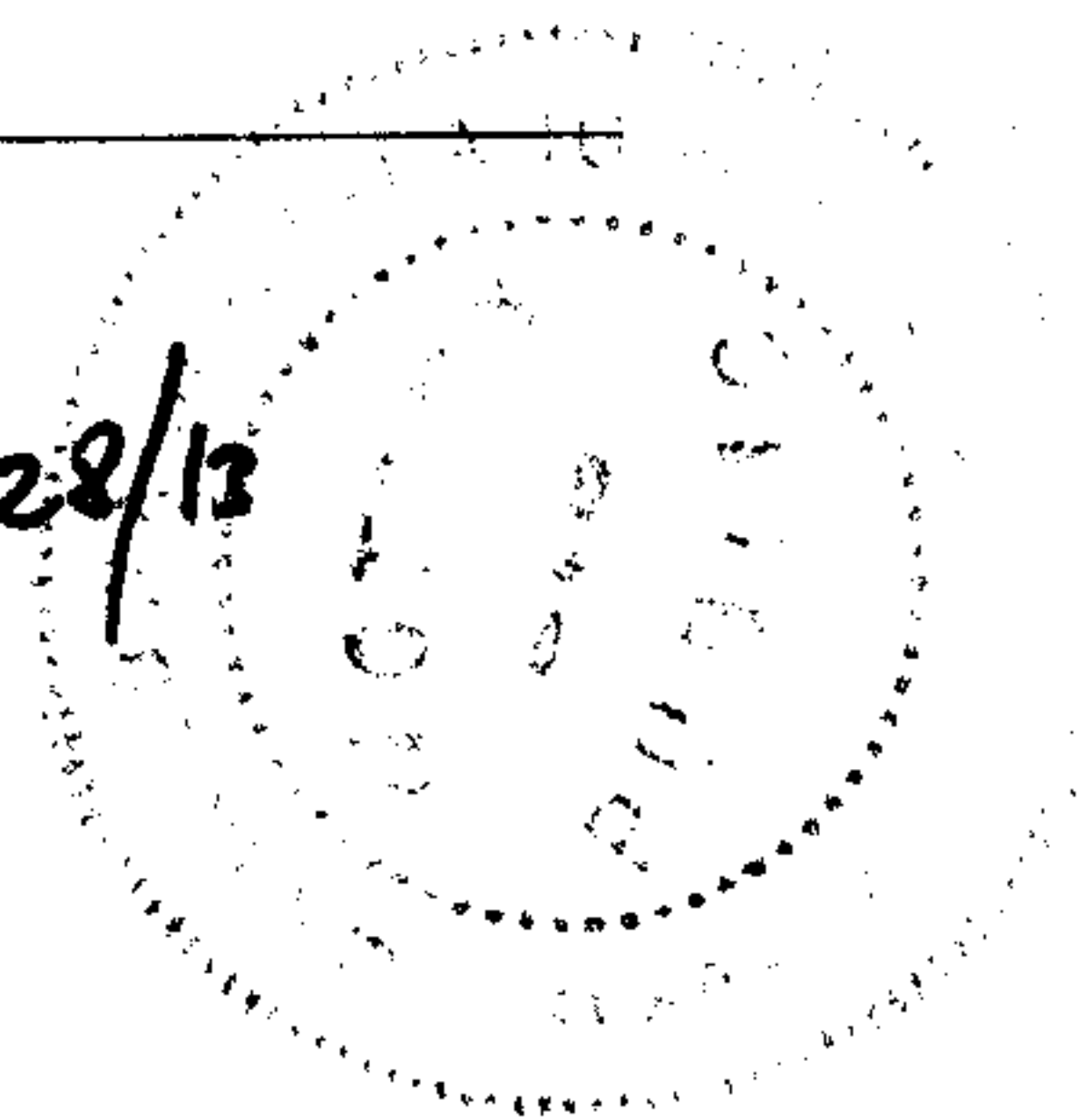
