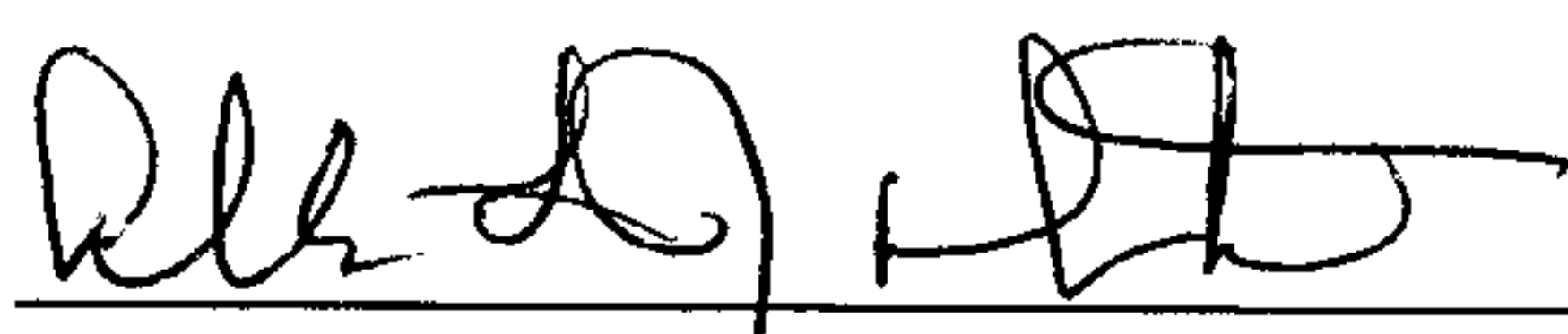
Mineral and mining rights excepted. Subject to current taxes, easements and restrictions of record.

\$88,000.00 of the consideration was paid from a mortgage loan closed simultaneously herewith.

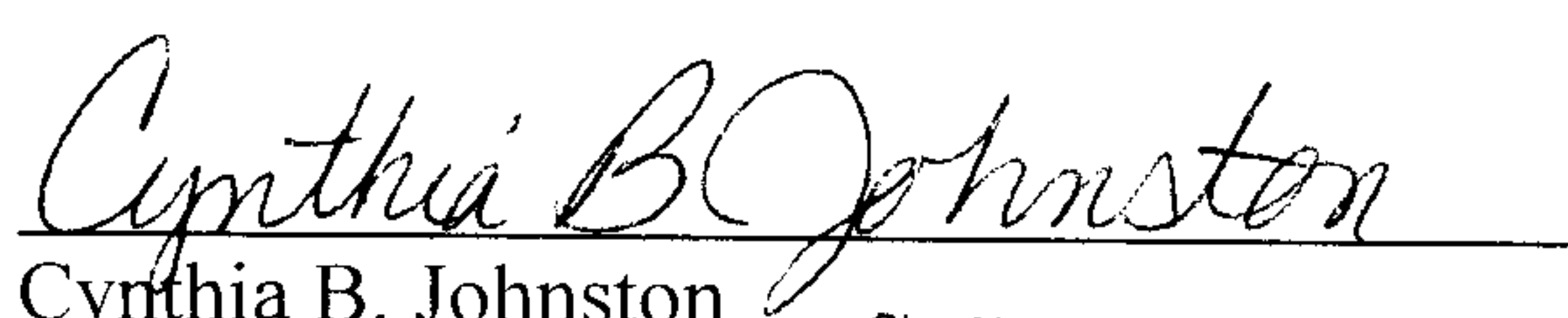

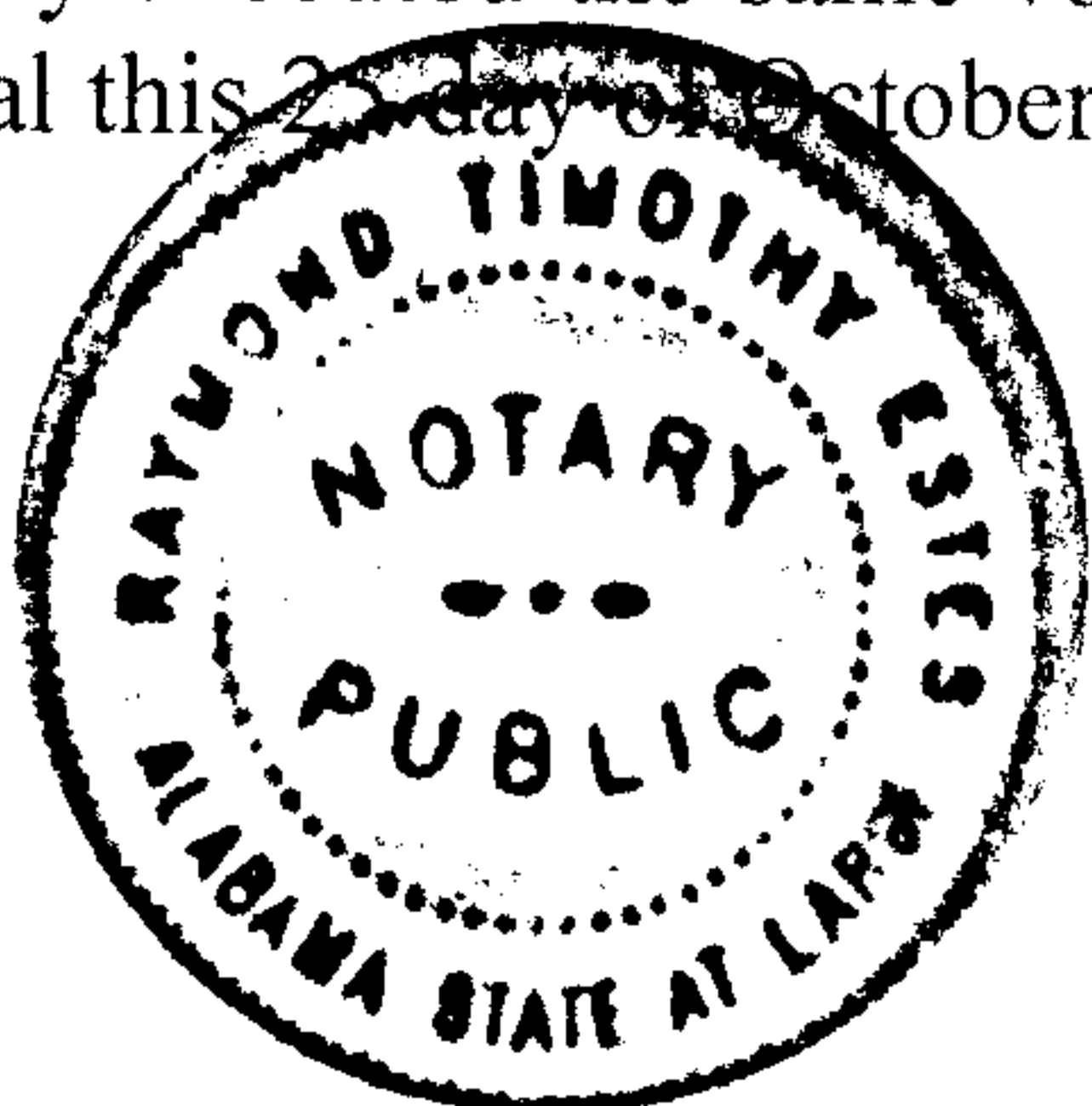
